NFPA 1033

Compliance with NFPA 1033 (2014) Chapter 1 – This chapter identifies the minimum job performance requirements for fire investigators. More specifically section 1.3.7 details what the fire investigator must maintain at a minimum and up-to-date basic knowledge of the following topics beyond a high school level. They fall into 16 categories and they may be maintained by attending formal education courses, workshops and seminars and/or through professional publications and journals. The categories are listed below and are supported by the applicable training that corresponds with each competency. This list is not all inclusive and will not reference all courses that may have provided instruction on a variety of NFPA 1033 related topics simultaneously.
